# INFORMATION PURSUANT TO ARTICLES. 13 - 14 OF EU REGULATION 2016/679 (GENERAL DATA PROTECTION REGULATION - GDPR)

according to the above mentioned regulation, the processing of data, will be based on the principles of correctness, lawfulness, transparency and protection of your privacy and your rights.

Fondazione Cineteca Italiana, with registered office in viale Fulvio Testi, 121 - 20162 Milano (MI) as the data controller, informs you in accordance with articles 13 and 14 of the gdpr 2016/679, that your data will be processed in the following ways and for the following purposes:

# 1. Object of processing.

The Controller, processes personal, identifying and non-sensitive data (in particular, first name, last name, e-mail, telephone-mobile phone number - hereinafter, "personal data" or also "data") communicated to Him.

# 2. Purpose of processing

The processing of your data has as its legal basis your consent and is carried out:

(a) for the exact execution of the contract signed between you and the Company Fondazione Cineteca Italiana;

(b) to fulfill pre-contractual, contractual and fiscal obligations (VAT tax register etc.), arising from existing relationships;

(c) to fulfill the obligations required by law, regulation, EU legislation or an order of the Authority;

(d) to exercise the rights of the Data Controller, for example the right of defense in court;

(e) to enable the sending of newsletters and/or mailing lists, for communications, organization of events and the further Services that may be requested.

# 3. Modalities of processing

The processing of your personal data is carried out by means of the operations indicated in Art. 4 No. 2) GDPR and namely: collection, recording, organization, storage, consultation, processing, modification, selection, extraction, comparison, use, interconnection, blocking, communication, deletion and destruction of data. Your personal data are subject to both paper and electronic and/or automated processing.

#### 4. Access to data

The data may be made accessible, for the purposes mentioned in point 2 above, to employees and collaborators of the company Fondazione Cineteca Italiana, in their capacity as data processors and/or system administrators.

# 5. Communication of data

Your personal data may be communicated to the Data Processors appointed by the Data Controller. We also inform you that the data collected will not be communicated without your explicit consent, except for necessary communications that may involve the transfer of data to public bodies, consultants or other parties for the fulfillment of legal obligations.

#### 6. Data Transfer

The management and storage of personal data will take place on servers located within the premises of the Data Controller and/or Data Processor.

The data will not be transferred outside the European Union. In any case, it is understood that the Data Controller will have the right to move the location of the server should the need arise. In this case, the Data Controller assures as of now that the transfer of data will take place in accordance with the provisions of the law.

#### 7. Data dissemination. Data Profiling.

Your personal data are not subject to dissemination. Your personal data are not subject to profiling

# 8. Rights of the data subject

The Regulations give the individuals whose personal data are processed specific rights, including:

(a) to obtain confirmation as to whether or not personal data concerning them are being processed and to obtain access to them (Art. 15 of the Regulations);

(b) obtain rectification of inaccurate personal data (Art. 16 of the Regulations);

(c) obtain the deletion of any personal data concerning him/her, in observance of the right to oblivion (Art. 17 of the Regulations);

(d) obtain the restriction of processing by the Data Controller (art. 18 of the Regulations);

(e) obtain their personal data in a structured, readable, and understandable manner, as well as obtain that such data be transmitted to another data controller without hindrance (Art. 20 of the Regulations):

(f) object to the processing of your personal data (Art. 21 of the Regulations).

You may revoke at any time the consent given to the Data Controller, without such revocation affecting the processing carried out up to that point by the Data Controller.

### 9. Methods of exercising rights

You may exercise your rights by written request sent to the Company, to the mailing address of the registered office or to the email address info@cinetecamilano.it

#### 10. Minors

The Holder does not intentionally collect personal information referring to minors. In the event that information about minors is unintentionally recorded, the Owner will delete it in a timely manner upon the users' request.

## 11. Duration of processing

We inform you that, in compliance with the principles of lawfulness, purpose limitation and data minimization, pursuant to Article 5 of the Regulations:

(a) your personal data will be kept for the entire duration of the contractual relationship with the company Fondazione Cineteca Italiana, and for the following 10 (ten) years for tax purposes only and to fulfill further legal requirements, and

(b) subject to your free and explicit express consent to the processing of your personal data for the purposes set forth in point 2 above by checking the appropriate box on the website https://www.cinetecamilano.it/ your personal data will be retained for 2 (two) years from the time they are provided.

#### 12. Data controllers, data processor and appointees

The Data Controller is Fondazione Cineteca Italiana. The updated list of data processors and persons in charge of the processing is kept at the offices of the Data Controller.
