Privacy policy in accordance with EU Regulation 679/2016

Dear Data Subject, We would like to inform you that "European Regulation 2016/679 on the Protection of Individuals with regard to the Processing of Personal Data and on the free movement of such data" (henceforth "GDPR") provides that the protection of personal data referring to individuals is to be considered a fundamental right of the individual. 1. CATEGORIES OF DATA

- Data provided voluntarily by the user. - constitute a database for reference purposes to which only FONDAZIONE CINETECA ITALIANA staff has access.

3. DATA CONTROLLER

3.1 PURPOSE OF DATA PROCESSING AND LEGAL BASIS

The processing of your data has as its legal basis the execution of the contract (letter a.), and the legitimate interest of the Controller (letters b. and c.)

a. for the management of the consulting contract and pre-contractual communications between you and the Controller;b. to fulfill the obligations required by law, regulation, EU legislation or an order of the Authority;

c. to exercise the rights of the Controller, such as the right of defense in court.

3.2 METHODS OF DATA PROCESSING

3.6 RETENTION PERIOD

Collected data will be retained for a period of time not exceeding the achievement of the purposes for which they are processed ("principle of limitation of retention", art.5, GDPR) or according to the deadlines provided by the legal regulations. Verification of the obsolescence of retained data in relation to the purposes for which they were collected is carried out periodically.

3.7. RIGHTS OF THE DATA SUBJECT

The data subject always has the right to request from the Data Controller access to his/her data, rectification or erasure of the data, restriction of processing or the possibility to object to processing, to request data portability, to withdraw consent to processing by asserting these and other rights under the GDPR by simple communication to the Data Controller.
